Professional Development - Part-time: Students who have not been accepted into a certificate or diploma program are considered Professional Development students and must pay the applicable PD tuition rate at time of registration (does not include text books) for each course. Entrance Scholarships: All high school applicants to full-time programs with an average of 80% or above will be automatically considered for scholarship.

Part-time Study Scholarships: Any students enrolled in a part-time program can apply for the scholarship upon completion of 50% of their program.
